

Congratulations on your Reservation!**Conditions/Recommendations for FRRPD facility site use**

- RESERVATION** Reservations are on a first come first serve basis. Reservations may be made at our FRRPD Activity Center, 1875 Feather River Blvd, Oroville, CA 95966. **Please know that our maintenance staff has taken every effort to provide you with a clean facility. Barbecue pits are cleaned and trash is removed daily. Sites are pressure washed weekly. Bring your rental contract and this form with you on the day of your rental.**
- DAMAGES** Any damage to Feather River Recreation & Park District Facility Sites because of this event will be repaired at renter's expense. Please inspect your site thoroughly upon arrival and contact maintenance at **712-1381** to report any issues.
- CLEAN UP** Renter is required to completely cleanup area at the conclusion of event. This includes all trash, decorations, food, and barbecue pits. We suggest bringing along rags and tablecloths to prevent accidental spills. Please be prompt in vacating your site, another party may have reservations after you and our staff will need time to clean the site. FRRPD staff will not be responsible for any items left behind.
- ALCOHOL** Fights, vandalism, destructive behavior are **not** permitted in our site facilities. Alcohol may be allowed for public events with proper permits and approval.
- CAMPING** Overnight camping is not permitted in FRRPD parks. As well as no campfires allowed in our parks or surrounding areas
- DOGS** FRRPD sites do allow dogs in our parks. However, please be considerate and keep your pet on a leash at all times and dispose of any waste properly. If you choose to have your dog off leash please utilize our Dog Park Facility at Riverbend Park.
- GATE CLOSURE** Be aware of gate closure times at FRRPD parks. Check the front gate upon arrival for times.
- NOISE** No loud or unusual noises allowed in FRRPD parks, including radios and headsets, which can be heard over 50 feet away.
- PARKING** You may only park in designated parking areas. FRRPD parks are equipped with plenty of parking space. Do not drive your vehicle on grassy areas or undesignated parking areas.
- SUBLEASING** Subleasing of your rental site is not permitted.
- CONTRACT** Rental contract must be signed by a responsible adult 21 years of age or older. Please remember your reservation has been set for a maximum number of people.

- SMOKING** Smoking is not permitted inside or within 25 feet, any FRRPD event facilities, including pavilions, buildings, restrooms, playgrounds, play feature or where children are gathered.

- CANCEL** FRRPD reserves the right to cancel any event and retain the full fee if the renter has knowingly made a false statement of material fact or has knowingly omitted to state a material fact in the rental application. All cancellations requested by renter must be done at least 1 week (7 days) in advance for refund to be valid.

- INSURANCE** A copy of all certificates of insurance and permits are due at least 1 week (7 days) prior to event or event will be cancelled. FRRPD is not responsible for actions, injuries or loss of property because of the event.

- DECORATIONS** State Fire Marshall requires that all hanging curtains, drops and other decorative material that are to be placed inside any of the District's facilities shall be made from a non-flammable material or shall be treated with a flame retardant solution or process approved by the State Fire Marshall. Balloons must be weighted down. Renters must remove all decorations upon leaving site, including streamers. Renters must furnish their own decorating supplies.

- ELECTRICITY** MLK & Palermo Parks- Park rentals **DO** have power available for limited use for an extra fee. Please note power outlets cannot accommodate bounce houses or other inflatables. Waterslides are not permitted at this time. _____ initial

- WATER & ELECTRICITY** Riverbend -Park rentals **DO NOT** have water or electricity available at the pavilions. Please note if you have bounce houses or other inflatables you will need to provide your own generators for said items. Waterslides are not permitted at this time. _____ initial

- GUESTS** Renter assumes full responsibility to the conduct of the guests at the function. Violence, loud behavior and unsupervised children are not permitted and will not be tolerated.

- HIRED HELP** All renters, caterer and visitor vehicles must remain clear of all no parking areas including bike paths, footpaths, and passenger loading zones.

- TRASH** All trash must be placed in receptacles provided. If trash will not fit in the receptacles, renter must take remaining trash and dispose of it properly.

- FIREARMS** Firearms or weapons are not permitted in FRRPD facility rentals or parks.
