# **SUMMARY**

August 2016 the Feather River Recreation & Park District Board of Directors approved to enter into agreement with Melton Design Group to revise the District's current Master Plan. This process began in October 2016 with a District Recreation Staff Workshop followed by a District Park Staff Workshop. Each group added valuable input to this process. Staff is compiling a detailed list of the ongoing adopted board goals and additional staff recommended goals for District Parks and Facilities. This list is intended to be used as a guide to reference during the Master Plan revisions as well as annual strategic planning. Staff is requesting that the Board of Directors take extensive notes on the Parks Tour and submit notes to staff of their ideas, visions and infrastructure needs for District Parks and Facilities. Once completed these notes will be added to the list that staff is preparing and its entirety will be presented for review and reference at the second Board Master Plan Workshop.

The second Special Meeting Board Workshop will be scheduled in the near future with Melton Design Group to prioritize the list and begin designing the Master Plan revisions. Once reviewed, this list will also be utilized to design annual strategic planning for the District.

2017 upcoming Master Plan Workshops include Public Engagement of core and outlying areas.
